**Admission Procedure**

- Admissions shall be made on merit basis of marks obtained M.Ed. (DE) Entrance Test conducted by SDLCE, KU.
- Admission shall be made on the above criteria by following the rule of reservation followed in KU.
- In event of a tie between candidates seeking admission to the M.Ed. (DE) programme, it shall be resolved on the basis of the total marks (Theory & Practicals) obtained by the candidate in the B.Ed.
- If the tie still persists, total marks obtained in the under-graduation examination will be the deciding factor.

- II. The candidates should submit the following certificates in 'ORIGINAL' at the time of counselling. Otherwise your candidature for provisional admission will not be considered.
- a) B.A./B.Sc./B.Com Degree/Provisional certificate
  - b) B.A./B.Sc./B.Com/other courses memorandum of marks (all the years/consolidated Memo)
  - c) B.Ed. Certificate (Degree/Provisional certificate)
  - d) Integrated community certificate in case of SC/ST/BC as per G.O. M/s. No.58/Social Welfare
  - e) Department dated.12-05-2007, indicating the sub-caste.
  - f) Original TC from the Institution last studied.
  - g) Original Migration Certificate from the University last studied, if other than KU.
  - h) Study Certificates of Degree, Intermediate, X and IX class for 'Local' claim.
  - i) Nativity certificate in respect of those candidates who have undergone the course by private study.
  - j) Service Certificate
  - k) Original Service Register updated and duly counter-signed by the DEO/Dy. Educational Officer..
  - l) No Objection Certificate from the concerned Head of the Institution.
  - m) Call letter.
  - n) Pass port size photographs (1)
  - o) Rs.200/- (Rupees two hundred) towards Counselling fee in cash.
  - p) A DD for Rs.35,000/- (Rupees thirty five thousand only) towards course fee in favour of "The Director, SDLCE, Kakatiya University from any branches of SBH / SBI / Andhra Bank payable at SBH , KU, Warangal. The fee will be accepted only on finalization of your admission.
  - q) **UNDER ANY CIRCUMSTANCES TIME WILL NOT BE GIVEN FOR SUBMISSION OF CERTIFICATES OR PAYMENT OF THE FEE. ADMISSION WILL BE FINALISED ON THE SCHEDULED DAY OF COUNSELLING ITSELF.**

NOTE : Candidates alone are responsible if any of the certificates are found to be false or forged.

### III. GENERAL INSTRUCTIONS:

1. In-service teachers with two years of regular service as on 30-04-2014 in Govt./Aided/MPP/ZPP/Govt. recognized Schools, after completion of B.Ed. programme with 55% of Marks.
2. There shall be a relaxation of five percent marks for SC/ST/OBC and other categories
3. The candidates who fail to attend the counseling on the specified date and time or unable to submit all original certificates or fail to pay the fees on the spot will forfeit their claim for admission.
4. The candidates are advised to come prepared to stay for a day or two beyond the actual date of counselling, if necessary.
5. If it is found that admission is secured on false evidence or by suppression of facts, the admission will be cancelled at anytime during the course of study and the candidate is liable for criminal prosecution, besides forfeiting fee.
